- 2. All tickets will only be sold to people who are 18 years of age or older.
- 3. Must be in the province of Ontario at the time of purchase.
- 4. Tickets are 5 tickets for \$10, 40 tickets for \$20, 250 tickets for \$50.
- 5. Tickets will be available at online at rcn5050.ca
- 6. Tickets will be sold using electronic raffle system supplied by Ascend Fundraising Solutions.
- 7. After buying, patrons will receive a confirmation e-mailed with their 50/50 registered numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.
- 8. The winning ticket number will be selected by a Random Number Generation (RNG) system from all raffle numbers sold for the draw.
- 9. The amount of the 50/50 will be posted online at rcn5050.ca.
- 10. The winning number will be announced by Rexall Care Network at a time and on a platform to be announced by Rexall Care Network on the Website. Immediately after the Draw Announcement, the Winning Number will be listed on the Website.
